**Susan Martin, Solicitor**

Susan founded her practice in 2004. She is President of the DSBA, a Council Member of the Law Society of Ireland and is a Rules of Court enthusiast. She has co-authored a number of legal textbooks and currently serves as Commandant in the Army Reserve.

**Remy Farrell SC**

Remy is a graduate of UCD. He was called to the Bar in 1997 and to the Inner Bar in 2011. Remy has acted for the state and defendants in some of the country's highest-profile criminal trials arguing before the Central Criminal Court, Court of Appeal and Supreme Court. In recent years his practice has become more focused on white-collar crime and regulatory law where he has regularly appeared before tribunals of inquiry including the Tribunal into Protected Disclosures and the Central Bank Inquiry concerning the Irish Nationwide Building Society. Remy is the co-author of 'White-Collar Crime in Ireland: Law and Policy' and 'The European Arrest Warrant in Ireland'.

**Kate McKenna, In - House Legal Counsel**

Kate McKenna is in-house legal counsel for Frontline Ventures, a venture capital firm based in Dublin with offices in London and San Francisco. She is a qualified Irish lawyer having trained in one of the big five firms in Dublin. She is a member of the Council of the Law Society of Ireland since November 2022 and sits on a number of standing and non-standing committees including the technology, in-house and public sector and regulation of practice committees. She lectures on the Law Society Diploma in Technology and IP law course on the topics of copyright and legal technology. She is also a founding committee member of the Disability Legal Network which is working to bring about a more inclusive legal sector in Ireland. She has published writings on topics such as assistive technology in the legal sector, AI and bias and most recently contributed to a round table discussion last October which looked at the state of lawtech in the Irish courts and the wider legal profession.
