The Family Courts Bill 2022 will introduce the most extensive changes to the practice of family law in Ireland this century. Among the proposed changes are:

- The establishment of a specialist family court division in each jurisdiction with a principal family law judge
- A set of guiding principles to be applied in all family law cases
- An increase in the jurisdiction of the District Court to deal with divorce, judicial separation, civil partnership and cohabitant cases, an increase in the monetary jurisdiction of the District Court for these cases to €1 million.
- Proposal for joint applications for divorce and judicial separation

While most of the changes are welcome and progressive, the proposed transfer of divorce and judicial separation cases to the District Court, in particular, is a matter of serious concern for practitioners given the summary nature of District Court proceedings and due to the significant volume of caseload borne by the District Court.

DSBA Family Law Committee Chairperson Cliona Costelloe will chair a discussion on the Family Courts Bill with Chairperson of the Child and Family Law Committee of the Law Society Peter Doyle and former chairs Keith Walsh and Helen Coughlan. They will discuss:

- 1. The Family Courts Bill
- 2. The fatal flaw in the bill and consequences for practitioners
- 3. What the DSBA and Law Society can do to fix the problems
- 4. Discussion and Q&A
